### 1. Call to Order:

# 4. Minutes of the meeting of October 14, 2024.

### 5. Examination Manager's Report for the month of October 2024.

Trustee White inquired about the decrease in female mosquito population, Manager Cardenas stated that it was due to treatments and the weather. He also inquired about the modified mosquito technology and Manager Cardenas responded it is in regard to the sterilized male mosquitoes that are used to reduce mosquito populations. The purpose that I attended is to keep updated on the topic.

Trustee Schock inquired about the Solano County Local Agency Formation Commission (LAFCO) in regard to the Municipal Service Review (MSR).
